- Come to each session prepared to talk about the book; dependent on the size of the book, this may be part of or the full book (which will be decided upfront) so that each person has enough time to read the parts being discussed
- 2. Discussion of the book will start at 19:00 sharp. For the period of the book discussion, the discussion must be kept to the book. Be present in this, and try to avoid any distraction (such as from phones, other people, children or pets)
- 3. Discussion and debate is integral to the book club. Please be considerate of the fact that everyone is likely to want to input into the discussion, so do not hog the discussion time. Encourage participation from everyone and give them an opportunity to speak
- 4. Be aware that we want a wide discussion on different areas of the book. I, Jack, will aim to keep us on track in this regard
- 5. Listen to and respect the opinions of others. If you are to disagree with an opinion, you must do so politely. Offensive language, raised voices, or angry tones are not allowed
- 6. Each member is to provide a short bio, to be included in the members' list. This will be made available to all members to help us get to know each other, particularly where there are new members
- 7. Payment will be taken for as long as you are a member, whether or not you attend the meet up.
